Following receipt of your completed Certificate of Finance form and official letters from your bank or lending institution, we will assess your file to affirm your eligibility to receive the I-20 form. This Certificate of Finance form must be completed before the University of the Virgin Islands can issue a visa eligibility document. The amount of money your certify as being available to finance your studies at the University of the Virgin Islands must equal tuition fees plus living expenses for the nine month academic year, and summer academic and living expenses.
