## Approval of Minutes June 19, 2021 Meeting

#### PRESIDENT'S REPORT

The President's Report for this reporting period is organized into two sections. Part I provides highlights of new and ongoing presidential initiatives and institutional accomplishments since the last report. Part II highlights major accomplishments within the framework of *Greatness Through Innovation*, the University's current strategic plan.

This framework has been adopted to ensure that all Components and Departments across the University are focused on areas that the University has determined are critical to our future success. I continue to be extremely impressed with the productivity and commitment of our University's students, faculty, staff and administrators.

#### STUDENT ACHIEVEMNETS

**George Francis**, a UVI senior, communication major and contributing writer for UVIVoice2.0, participated in a special virtual White House briefing with Karine Jean-Pierre, Principal Deputy Press for the Biden-Harris Administration, on September 10 with student journalists from 21 Historically Black Colleges and Universities (HBCUs). Ms. Jean-Pierre is the first Black woman to serve in this capacity in the White House in the past 30 years. In the half-hour live streamed event, Francis had the opportunity to directly interview Ms. Jean-Pierre as a professional journalist would in a White House press conference.

The event was part of the first ever White House HBCU Week held in collaboration with the White House Initiative on HBCUs. When Francis was called on to interview Jean-Pierre he asked, "My class at UVI is reading a book entitled Diversity Matters in the 21st century which includes a chapter about you, the BLM Movement and Anglophone African-Caribbean Impact. We have discussed your blueprint for activism and sections

from your book "Moving Forward." Might you expand on your thoughts that topics such as mental illness, depression and suicide must be acknowledged as serious social ills in communities of color and become part of a larger dialogue in mainstream society?"

The Creative Leadership for Innovation and Change (CLIC) doctoral program welcomed its sixth cohort this Fall. The cohort of 23 students are from a wide range of geographical locations including Nigeria, Ghana and Ethiopia. The CLIC PhD program continues to provide support to students across all cohorts. To date, 24 students have completed the program.

UVI students in the BUS 436 Strategy class led by *Dr. Glenn Metts* successfully placed in their first Global Top 100 finish in the Business Strategy Simulation Game. The Business Strategy Game is the most widely played computer simulation in the strategic management market and is used in business schools all across the world. Each company in the industry is managed by a team of student(s)/player(s) who must match their strategic wits against the other company teams. Rankings of the best-performing companies worldwide are based on Overall Score, Earnings Per Share, Return on Equity, and Stock Price.

Our students' placement in the Global Top 100 is a remarkable achievement, especially considering that 46,288 students from 47 nations participated on 450 different campuses during this time span. TEAM A consists of the following students:

In collaboration with the Office of the Provost, the School of Nursing developed a nineday study abroad experience in Costa Rica, which was specifically targeted at nursing majors. Five students travelled to Costa Rica in July along with two faculty members from the School of Nursing. The students engaged in nursing-related experiences at local hospitals and medical clinics.

The St. Thomas Chapter of the Golden Key International Honor Society received Gold Standing for meeting the Chapter Standards during the 2019-2020 Academic Year. Membership in Golden Key International Honor Society is based on academic achievement, but the organization's mission of each member realizing their full potential can be found in three pillars: Academics, Leadership, and Service. **Madyson Miller** received a \$4,500 scholarship to attend the Heirs to Our Oceans (H2OO) Summit of Empowerment and Leadership (SEAL) in Hawaii, July 4-17. Miller was also hired as a Community Engagement Specialist to support VI-EPSCoR research initiatives on both UVI campuses.

Nadege Barber, Communication minor, received special recognition from the American Association of State Colleges and Universities (AAASCU) for her participation in the 2021 Washington Center Academic Internship summer internship program. Ms. Barber was also among 19 college finalists to participate in an innovative 2021 Summer Internship program sponsored by INROADS, Inc. She represented UVI and the communication unit, alongside students from other HBCUs. The cohort of students was selected to launch PROPEL, a virtual/physical campus in Atlanta that will serve as a global digital hub for leadership and career development for more than 100 HBCUs. Ms. Barber also completed the interview process and was selected to participate in Thurgood Marshall College Fund's 21st Annual Leadership Institute. "Level Up!" to be held October 18 - October 21, 2021.

Communication students, **Karon Reynolds, Saida Marreo, George Francis**, and **Kalyna Nelsen** submitted audition videos to UVI Public Relations Media team and were selected as talent to film local television and radio advertisements.

The University issued a press release about Francis' participation in the national press briefing which was published in the VI Daily News, The VI Consortium, the VI Source, and the St. John Tradewinds. The press briefing with Francis was also hosted on the University's Facebook page and garnered a reach of over 21,000 people and 1,350+ reactions, comments and shares.

Status Report on Fundraising

## Total contributions to date for fiscal year 2020 (Oct 1, 2020 – September 30, 2021) \$3.341.979

At the invitation of the chair of the Committee, VP Mitchell Neaves reported that the Committee discussed the strategy employed by the University to secure charitable contributions during fiscal year 2021 from private donors. The majority of private funding is being donated by corporations and foundation funders. However, UVI alumni contributed the overwhelming majority of gift received by the university. Seventy-eight percent of current donors identify as graduates of the University. President Hall is realizing success in his efforts to attract private funders to support the UVI School of Medicine and the Business and Innovation Center.

#### Goal for Fiscal Year 2021

The Committee made a recommendation for consideration by the full Board, to set the fiscal year goal for donations at \$4M and alumni participation goal at 20 percent.

A motion was made by Trustee Callwood which was seconded by Trustee Williams to approve a resolution approving the Fundraising and alumni giving rate for FY2022. The motion was approved unanimously. Tge resolution was approved.

## **Approval of Trustee Emeritus Status**
